Dear Lincoln Park neighbors,

You are receiving this letter as an abutter of the Lincoln Park, located on Lincoln Street. During 2022 Annual Town Meeting, funding was appropriated to complete a Master Plan of the Lincoln Park. This plan will provide the Recreation Committee and the Town a resource to assist in the future planning for both the active and passive uses of the park. The current 5-year capital improvement plan (FY23-FY27) includes several requests specific to the Lincoln Park which include, end of life replacement of; the (3) synthetic turf athletic fields, the outdoor fitness stations and play structure. Additionally, the parking lots and traffic flow continues to be a concern and needs to be assessed for spaces and access.
